

DISCLAIMER OF LIABILITY

Attendees younger than 18 years old at inter airport Europe

Mack-Brooks Exhibitions Limited, Part of RX ("RX") is the Organiser of the event referenced above (the "Event").

3. Minors are not permitted to touch or use the exhibits or participate in the Event in any way. The Attendee shall, at all times whilst at the Event, supervise the Minor and be solely liable for all actions of the Minor, including for any injury suffered by any person, directly or indirectly, as a result of the attendance of the Minor as well as for any and all damage to the exhibition halls, exhibitor stands and/or goods on display at the Event or any other damage howsoever caused, directly or indirectly, as a result of the attendance of the Minor at the Event.
